6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2077/10/22 (04 Feb, 2021) at the **Baraha Pokhari Rural Municipality Office, Khotang**. Bids must be valid for a period of 120 (One Hundred Twenty) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
